Customer will return mannequin parts in bubble wrap packaged in box as originally shipped
 Customer will return glass bases disassembled with all screws and hardware
 Customer will accept delivery and/or have merchandise available between **9AM** and **5PM** on all delivery and pickup dates if third party shipping is used unless noted elsewhere in contract
 If customer is responsible for transportation, customer will return merchandise by **4:30pm** on Return Date
 Mannequins returned after **5pm** on Return Date will be considered late and will accrue late fees:
Female mannequin: \$30 per extra day, Male mannequin: \$35 per extra day
 Customer must notify NYC Display immediately if damage occurred in transit if using third party shipper
 The following types of damage will result in a **\$50** fee: Broken finger; noticeable serious crack on mannequin that occurs between the bottom of the breasts to the top of the head, and damage to plastic pieces that connect the waist to the torso, and any missing parts. The maximum late fee and damage fee per mannequin is **\$50**
 Customer will be assessed an additional fee of **\$100** per incident if third party shipper is unable to deliver or pickup merchandise as noted within contract
